Clackamas County Leaders & Region-Wide Colleagues Stand United In Condemnation of
County Commissioner Mark Shull and His Social Media Posts.

Together as elected leaders we represent the cities and the people of Clackamas County, and we stand united together and with other leaders in the region, in utter horror over the comments written, shared, and endorsed by County Commissioner Mark Shull on social media. His hateful, inflammatory rhetoric cast dangerous bigotry and intolerance on many historically marginalized groups, including Muslims, immigrants, and transgender people. The volume and breadth of the comments demonstrate a severe disconnect with the shared values of Clackamas County, and we have lost any trust in his ability to serve our shared constituents of the county equitably and justly. **We call on Commissioner Shull to resign immediately.**

To those targeted by Commissioner Shull, we stand with you and take seriously our job to provide equitable representation, protection and service to every member of our communities. We uphold our commitment to protect all of the people we represent and to speak out against racism, hate, bigotry and other forms of intolerance that have no place in our society.

As elected leaders we know our words matter and carry force. The signatories to this letter represent a wide continuum of perspectives and beliefs, and we respect that diverse ideas generate the sound policy that in turn moves our communities forward. What is not open for debate is the worth of all people regardless of their race, religion, national origin, ethnicity, gender identity, or otherwise. We cannot work with a County Commissioner who has clearly demonstrated a belief quite to the contrary and that puts our residents and communities at risk.

Oregon City, OR – Jan. 14, 2021: Today the Clackamas County Board of Commissioners formally censured Mark Shull, including calling for his resignation.

The resolution of censure text, passed 5-0 by the full commission, can be found below.

A RESOLUTION OF THE CLACKAMAS COUNTY BOARD OF COMMISSIONERS IN THE MATTER OF CENSURE OF NEWLY-ELECTED COMMISSIONER MARK SHULL

Whereas, the Clackamas County Board of Commissioners prides itself in serving as the governing body of an organization that provides a multitude of critical public services to more than 400,000 of its residents; and

Whereas, in the provision of these services, and our representational democracy, the Board of County Commissioners finds that it is imperative that these services be provided to all residents fairly and even-handedly without bias based on gender, race, color, national origin, religion, familial status, disability, marital status, source of income, or sexual orientation (including gender identity); and

Whereas, in 2015 the Board of County Commissioners affirmed its commitment to valuing diversity, equity and inclusion in Clackamas County by adopting Resolution No. 2015-96, a copy of which is attached hereto and incorporated by this reference herein; and

Whereas, recently, we all have learned of certain comments posted on social media by Mark Shull, a newly-elected County Commissioner; and

Whereas, the posted comments are derogatory, offensive, insensitive, and racist; and

Whereas, recently, we all have learned of certain comments posted on social media by Mark Shull, a newly-elected County Commissioner; and

Whereas, the posted comments are derogatory, offensive, insensitive, and racist; and

Whereas, by these statements, Commissioner Shull has imputed to Clackamas County a reputation of racist, sexist, and religious insensitivity and intolerance; and

Whereas, by these statements, Commissioner Shull has damaged the reputation of Clackamas County both as an organization and a governmental entity; and

Whereas, Commissioner Shull's statements and opinions are detrimental to the trust and confidence of the residents of Clackamas County and the Board of Commissioners' ability to ensure the delivery of services to the County's residents; and

Whereas, as a result of this conduct, the Board of County Commissioners has lost trust and confidence in Commissioner Shull and his ability to continue to provide leadership;

NOW, THEREFORE; BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS THAT:

Section 1: The Board of County Commissioners condemns and denounces the derogatory, offensive, insensitive, and racist statements posted on social media by Commissioner Mark Shull. This Resolution constitutes official censure of Commissioner Mark Shull for his conduct described herein; and

Section 2: It is the consensus of the Board of County Commissioners that it is in the best interest of Clackamas County that Commissioner Mark Shull resign his Commission post effective immediately.

SALEM – In response to statements made by Clackamas County Commissioner Mark Shull, legislators who serve Clackamas County released the following statement:

“We stand firmly united in our condemnation of the disgraceful social media posts and call for the resignation of Clackamas County Commissioner Mark Shull. He has repeatedly used language that is racist, Islamophobic, xenophobic, and transphobic. The disinformation he peddled in the wake of the tragic Labor Day wildfires is unconscionable. These comments are not only offensive, they are also extremely dangerous.

“In a moment when too many give in to their hatred and deny facts, we’ve seen firsthand in Salem and in Washington, D.C. in recent weeks just how destructive this kind of language can be. Hatred like this has no place in our society. Rather, we must do all we can to collectively confront our past and to address the continued impact that systemic racism and bigotry have on immigrants and communities of color.

“Furthermore, Commissioner Shull’s statement in response to these social media posts becoming public is not remotely acceptable. It is a non-apology and does not show the necessary regret he should have for so consistently using dehumanizing language to describe other people. He has not offered a true, sincere apology and shown he is willing to take real, concrete steps to start a healing process for those who he’s repeatedly hurt with his hateful rhetoric. He should resign immediately.”

Clackamas chair, department heads ask Mark Shull to resign

Move follows letter issued today from county department heads calling on board to act and for Shull to resign.

UPDATE 3:40 P.M. WEDNESDAY, JAN. 13: Clackamas County Chair Tootie Smith is now calling on Mark Shull to resign his seat on the board of county commissioners.

"In support of the greatest good of citizens of Clackamas County, I have asked that Mark Shull resign from the Board of County Commissioners immediately," Smith said in a statement Wednesday afternoon.

The move follows publication of a letter carrying the signatures of nearly every department head, deputy director and senior manager employed by Clackamas County which called for the board of county commissioners to condemn statements made on social media by Shull and suggested he resign as commissioner following publication of heinous [statements](#) on his personal Facebook page representing racist, transphobic, Islamophobic and anti-immigrant views.

"In all the power dynamics of the employees here in the county, those of us at the top of that structure have the most responsibility to raise our voice," the Jan. 13 letter read. "We respectfully call on you to condemn the comments of any commissioner who works against equity and inclusion of all of our residents, and to prioritize education and re-commitment of the current Board of Commissioners to the County's policies on anti-racism without delay."

Calls for Shull's resignation continue to mount — now including almost every elected official in the county outside of the board itself — following Monday's publication of a blog outing odious comments the recently-elected county commissioner has made over the past two years. The comments were catalogued in a blog by Jennings Lodge resident Cris Waller.

The letter was issued to both the board and County Administrator Gary Schmidt as a message that county employees vehemently oppose the views expressed by Shull.

"We believe Mr. Shull should immediately resign his position," the letter said.

Schmidt has worked tirelessly in recent years to foster a culture of inclusion and put equity at the forefront of every conversation. Part of that effort includes the hiring last year of Martine Coblentz, county equity and inclusion officer, who has led efforts to improve workplace culture and reform hiring practices through an equity lens. Coblentz is one of the nearly two dozen county leaders who signed Wednesday's letter.

Schmidt responded to the letter with an email sent out to all county employees early Wednesday evening thanking them for their resolve and commending their hard work through extraordinary circumstances.

"Clackamas County is strengthened and enriched by our diversity. We are committed to providing a safe and inclusive community for all County employees, residents and visitors," Schmidt wrote. "The County remains steadfast in our commitment to advancing diversity, equity and inclusion internally for employees and externally for our residents. Violence or harmful statements do not reflect the values of Clackamas County or its employees."

They were ugly, divisive and hurtful beliefs that are offensive to my core values and those of this community. We need public servants who will honor differences and respect all people-- whether that is in their private lives or their public capacity. We need leaders who will bring us together, not drive us apart," Drazan said.

Documenting Mark Shull's Racism

Mark Shull, the newest Clackamas County Commissioner, has made no secret of his views on immigrants, people of color, Muslims, and other marginalized groups. All of the quotes below were taken from posts on his public Facebook account, <https://www.facebook.com/groups/203416086773615/user/100037314138604/> I offer a selection of quotes below, followed by copies of these and other posts.

NOTE: As of 1/12/2021, Mr. Shull has removed access to his Facebook account.

Anti-Muslim Comments

- Stop the enemy while the enemy's strength is still relatively weak in comparison to friendly forces...the most menacing threat to US national security is the incursion of Islam into our society...It is time for a new D-Day, one that is appropriate for the threat. (Nov. 3, 2019)
- Islam is in total conflict with America, with the Constitution and with the Christian values upon which the USA was founded. ..Islam is not here to become part of America. Islam is here to establish the Caliphate. Once the caliphate is established, YOU DIE...Go to any Islamic nation, preach the Bible, you die. (Aug. 26, 2019)

- Immigrants with tuberculosis and polio are welcome, but you'd better be able to prove your dog is vaccinated. (April 5, 2020)



In a briefing by Captain Mark K. Shull, USMC on Islam in the west. Amphibious Warfare School, Quantico Virginia, October 1985. In the last 39 years, nothing has changed from that briefing in 1985 regarding the Islamic threat to the USA.
