RE: REVISIONS TO PLANS, SPECIFICATIONS AND BIDDING

**DOCUMENTS** 

The following Addenda to the Project Plans, Specifications, and Bidding Documents shall be considered merged with the original bid package as if they were whole. The contractor shall acknowledge receipt of this Addendum in Section 24 of the Bid Proposal.

## BID DATE & TIME Changed to: July 2, 2025, 2:00 p.m.

- ITEM #1: A question was submitted about playground equipment, fitness equipment, playground safety surfacing and engineered wood fiber in playground area being Owner furnished Contractor Installed vs. Owner furnished Owner installed?
  - As a clarification, these items are now changed to Owner Furnished Owner Installed eliminating bid items 48, 49, 51 & 52.
- ITEM #2: For bid item 46, a question was asked about the number of Basalt Columns Vertical, it gives a quantity of 1 EA but there are 5 shown on the plans?
  - Specifications states that Payment for Boulder Wall will include vertical basalt columns at ends (4 total).
  - o There is only one of "Basalt column, vertical, freestanding".
- ITEM #3: A question was submitted about Bid item 43 which shows 84 LF but on the plans they measure out to 158 LF between wall A & B?
  - o As a clarification, bid item measures out to be ~ 160 LF between wall A & B
- ITEM #4: A question was asked about bid items #24 and #27. For clarification, the issue with the reinforced concrete is we were providing our quantities as square foot (SF), but they were reported as square yards (SY) in the bid document.



- o #24 Reinforced concrete pavement, 6 inches thick is 101 SY
  - $\sim$ 450 SF of reinforced concrete = 50 SY
  - $\sim$ 460 SF = 51 SY
  - TOTAL = 450 SF + 460 SF = 910 SF/9 = 101 SY
- #27 Thickened edge measure in LF is correct and located below the stamped concrete at the safety surfacing.
- ITEM #5: A question was asked about Spec section 32 91 13, 26.04, 7a. where it notes to "not include subtraction of 2" mulch for finish grade calculation". Is that 2" referring to the bark mulch layer in planting beds, or the 2" 1/4-10 aggregate called out in the specs?
  - o To clarify, it is referring to Bark Mulch.
- ITEM #6: A question was asked "Are the quantities for bid items 16 & 17 figured after the site has been stripped?
  - o Yes
