# A. URA Resolution No. 317

A Resolution Of The Urban Renewal Agency Of The City Of Wilsonville Adopting The Budget, Making Appropriations, And Declaring The Intent To Collect Tax Increment For Fiscal Year 2021-22.

Ms. Jacobson read the title of URA Resolution No. 317 into the record.

Keith Katko, Assistant Finance Director presented provided the staff report and presentation. The PowerPoint has been added to the record.

# **Motion:**

Ms. Linville moved for approval of the 2021-22 Proposed Budget for the Urban Renewal Agency in the amount of \$62,266,300. (Sixty-two million, two hundred sixty-six thousand, three hundred dollars) and set the Increment Assessed Value in the West Side Plan District to approximately \$401,210,000 (four hundred one million, two hundred ten thousand dollars) which will generate an estimated levy of \$5,000,000 and set the Increment Assessed Value in the Year 2000 Plan District to approximately \$322,000,000 (three hundred twenty two million) which will generate an estimated levy of \$4,200,000. And levy the full amount of the "divide-the-taxes" amount for the Coffee Creek District. Ms. Lehan seconded the motion.
